Government Response to the House of Lords Select Committee Report on Stem Cell Research, Great Britain. Dept. of Health, Stationery Office, 2002, 0101556128, 9780101556125, . This document details the Government's response to the Committee's report (HLP 83(i), session 2001-02; ISBN 0104420529) on the issues raised by recent developments in stem cell research. The Government acknowledges the exciting prospects for developing new treatments for life threatening diseases and injuries, and notes that long term investment is needed to ensure this potential is realised. Embryonic stem cell research will be an essential part of research for the foreseeable future, although work into other sources of cells should also continue. The 1990 Human Fertilisation and Embryology Act and the Human Fertilisation and Embryology (Research Purposes) Regulations 2001 provide the most comprehensive set of controls over embryo research in the world, with both basic and applied research covered. The Government welcomes the Committee's support for the prohibition of any attempts to implant a cloned embryo into a woman in the UK (as set out in the Human Reproductive Cloning Act 2001), and states its intention to promote a draft UN convention to ban human reproductive cloning. Further scientific developments will be kept under review by both the Government and the Human Fertilisation and Embryology Authority (HFEA)..
