2nd ed. of the Revised Statutes of 1873, Wash., GPO, 1878. Cite as R.S. (1878). LLMC's offering includes two supp. vols. by Richardson, publ. in 1891 & 1895, carrying the work through the 53rd Congress, all publ. (The 1st ed. aroused dissatisfaction because of numerous errors and the perception that the revisers had somewhat exceeded their authority. Thus, this 2nd ed. was published under the authority of the Congress, making substantial corrections to the Revised Statutes of 1873. However, since it was not reenacted into positive law by Congress, where the corrections differ from the text of the Statutes at Large from which they are derived, the latter governs as the "best evidence" of the law.") (Chronological note clarifying the coverage of the above four titles: The Maritime Administration, which included the Federal Maritime Board, was established in 1950 within the Dept. of Commerce. In a reorganization of 1961, the Federal Maritime Board was abolished. Its subsidization functions were assigned to a new entity, the Maritime Subsidy Board, which remained within the Maritime Administration in the Dept. of Commerce. Its other functions were assigned to an independent agency called the Federal Maritime Commission. Finally, in 1981, the Maritime Administration and the Maritime Subsidy Board were transferred to the Dept. of Transportation.)

--- Federal Housing & Home Finance Agency Annual Reports: 1947&#8211;1964. Cite as HHFA Ann. Rep. (This agency, founded effective July 27, 1947 became part of HUD effective Nov. 9, 1965.) (LLMC still needs to locate the years 1947-1952, 1956 & 1960 for filming. When completed

this title will be made available as LLMC 90-376)

(Note that part or all of seven Interior Dept. titles, as indicated below, are also included in LLMC's Native American Collection, which is described in Section 10 of the LLMC sourcebook. If your library holds that collection, you already hold these titles, or the parts thereof which are listed. Note also that many other smaller titles originating from the Interior Department, which for space reasons are not listed here, are included in the Native American Collection.)

--- Index/Digests of Decisions of the Department of the Interior: 1893&#8211;1994. (Includes a special volume covering all important unpublished decisions, memorandums, memorandum opinions, and Solicitor's opinions for the 1943&#8211;54 time frame. Later volumes do not have this extended coverage, but do cover some of the unpublished decisions. Since 1991 this index covered Interior Decisions, and the Interior Boards of Contract, Indian, & Land Appeals, and the Decisions of the Office of Hearings & Appeals. Supplements for this title will be filmed and delivered to subscribers as they become available) [Available on 138 24x fiche as LLMC 80-023 for \$207.00]
