Broadcasting,—A Motion was made, and the Question being proposed, That this House approves the Agreement (Cm. 6872) dated 30th June 2006, between the Secretary of State for Culture, Media and Sport and the British Broadcasting Corporation, which was laid before this House on 3rd July 2006—(Secretary Tessa Jowell);

An Amendment was proposed to the Question, in line 4, at the end to add the words 'but regrets that the proposed BBC Trust will not be sufficiently independent as a regulator for the BBC; believes that the National Audit Office should have full access to the BBC's accounts; is concerned that the announcement of the licence fee has been delayed without adequate explanation; further regrets the fact that the Charter Renewal process has been separated from the final licence fee decision; and further believes that the BBC's bid for an increase in the licence fee of 2.3 per cent. on top of the Retail Price Index is excessive.'—(Mr Hugo Swire.)

Climate Change Levy,—A Motion was made, and the Question being put forthwith, pursuant to Standing Order No. 118 (Standing Committees on Delegated Legislation), That the draft Climate Change Agreements (Miscellaneous Amendments) Regulations 2006, which were laid before this House on 12th June, be approved—(Mr Michael Foster):—It was agreed to.

(i) BBC Outsourcing: The contract between the BBC and Siemens Business Services for the provision of technology services—National Audit Office review presented to the BBC Governors' Audit Committee, June 2006, by the Comptroller and Auditor General, and a response to the review from the BBC; and

Consolidation, &c., Bills,—Lynda Waltho reported from the Select Committee appointed to join with a Committee of the House of Lords on Consolidation, &c., Bills, to which the Parliamentary Costs Bill [Lords], the National Health Service Bill [Lords], the National Health Service (Wales) Bill [Lords] and the National Health Service (Consequential Provisions) Bill [Lords], now pending in the House of Lords, were referred, That it had gone through the Bills; and had agreed to a Report which

it had directed her to make to the House; and had directed her to report the Minutes of Evidence taken before it on 11th July.

Adjournment (Extradition Treaty between the USA and the UK),—Mr Nick Clegg, Member for Sheffield, Hallam, rose in his place and asked leave to move the adjournment of the House for the purpose of discussing a specific and important matter that should have urgent consideration, namely the Extradition Treaty between the USA and the UK; and the leave of the House having been given, the Motion stood over under Standing Order No. 24 (Adjournment on specific and important matter that should have urgent consideration) until the commencement of public business to-morrow.

Accidents Involving Animals (Strict Liability),—Ordered, That leave be given to bring in a Bill to amend the Animals Act 1971 to make it a defence in law for the owner of an animal involved in an accident to show that he took all reasonable steps to keep the animal in a secure enclosure; and for connected purposes: And that Mr Laurence Robertson, Mr Mark Todd, Mr Peter Atkinson, Angela Watkinson, Philip Davies, Mr Nigel Evans, Mr Richard Benyon, Kate Hoey, Miss Anne McIntosh, Mr Jeffrey M. Donaldson, Mr David Anderson and Lembit O-pik do prepare and bring it in.
